



Terms And Conditions Of Transact & Win Big Competition

1 The promoter

Nedbank Lesotho Limited, registration no I92/191 is a registered financial institution and credit provider in Lesotho. As the host of this this competition, we reserve the right to make it available to a selected group of clients.

2 Competition period

The competition starts on 12 June 2024, and ends on 27 November 2024 (competition period).

3 Who can participate in the competition

3.1 A participant (you, your) must:

3.2. be 18 years or older;

3.3 if a current Nedbank Lesotho client, ensure that your bank account is in good standing, which means it must not be in arrears or handed over for legal collection;

3.4 Employees of Nedbank Lesotho including their immediate family members, contract employees, directors, associated companies, agents, contractors and sponsors may not participate in the competition.

4 How to enter – Primary entry

To stand a chance to win a prize, you must:

4.1 Pay for goods and services by swiping or tapping your debit card on the Nedbank POS machines

4.2 Do a cash-out transaction (withdraw cash) at any selected qualifying store

4.3 Make payments or send money using online banking

4.4 Send money using Nedbank MobiMoney or Nedbank Money (Africa) App

4.5 Buy electricity or airtime using Nedbank MobiMoney or Nedbank Money (Africa) App

4.6 Do a “Send Money” transaction on the Nedbank Money (Africa) App

4.7 Pay for fuel at participating fuel stations on Nedbank POS machines

5 How to boost winning chances – Secondary entry

5.2 Purchase electricity or airtime for minimum of M200.00 on a qualifying week using any Nedbank Mobi Money, or Nedbank Money (Africa) app, or Nedbank online banking.

5.3 Above entries qualify for travel voucher prizes. A non-Nedbank client may sign-up for a free MobiMoney account by self-enrolling. User simply needs to dial *120*141# using their Lesotho registered mobile phone, and capturing Name and Surname as they appear on said individual's Lesotho national ID, no middle name.

6 The prize

The said winner will be advised of the purpose of the call, then requested to confirm their identity. Winner will then be guided on the next steps including radio and social media publication, as well as prize-collection terms. Winners will also be announced on Nedbank Lesotho's radio shows. All winners will be photographed for reporting purposes, as well as promotional purposes limited to the applicable campaign only, e.g. testimony of previous winners.
