

NEDBANK RUNNING CLUB CHALLENGE COMPETITION (NEDBANK RUNNING CLUB ATHLETES ONLY)

COMPETITION TERMS AND CONDITIONS

1. The promoter of the competition is Nedbank Limited (“**Promoter**”).
2. The competition will commence on 11 July 2020 and will close on 24 October 2020.
3. The competition will comprise four challenges taking place between July and October 2020.

4. WHO CAN AND CANNOT ENTER THE COMPETITION

- 4.1. All participants (“**Participants**”) in the competition must be:
 - 4.1.1. over the age of 18 and must be a South African citizen or permanent resident with a valid South African ID number.
 - 4.1.2. Members of the Nedbank Running Club.
 - 4.1.3. All Participants must have an active, public Strava account.
- 4.2. The following persons however are not allowed to enter into the competition:
 - 4.2.1. the directors and employees of the Promoter, or their spouses, life partners, business partners or immediate family members;
 - 4.2.2. the Promoter’s agents, consultants, marketing service providers (including directors, members, employees, or their spouses, life partners, business partners or immediate family members); and
 - 4.2.3. the company who has supplied the prize (where applicable) (including spouses, life partners, business partners or immediate family members);
- 4.3. Failure to satisfy any of the abovementioned eligibility criteria will result in a Participant not being able to win any prizes.

5. NEDBANK RUNNING CLUB CHALLENGE COMPETITION DATES

- 5.1. The Nedbank Running Club Challenge will consist of 4 separate challenges, taking place over 4 months. 1 challenge will go live each month.
- 5.2. Each challenge will require Participants to run a minimum distance that is specified in the challenge breakdown.
- 5.3. The 4 minimum distances will be a 10km, 21.1km, 32 and 42.2km run.

- 5.3.1. **Challenge 1** – Nedbank Running Club 10km Challenge (50m elevation): Must be completed on 11 July 2020 and uploaded onto Strava no later than 12 July.
- 5.3.2. **Challenge 2** – Nedbank Running Club 21.1km Challenge (50m elevation): Must be completed on 8 August 2020 and uploaded onto Strava no later than 9 August.
- 5.3.3. **Challenge 3** – Nedbank Running Club 32km Challenge (100m elevation): Must be completed on 12 September 2020 and uploaded onto Strava no later than 13 September.
- 5.3.4. **Challenge 4** – Nedbank Running Club 42.2km Challenge (100m elevation): Must be completed on 10 October 2020 and uploaded onto Strava no later than 11 October.

6. NEDBANK RUNNING CLUB CHALLENGE COMPETITION RULES

- 6.1. The competition will be run in accordance with the general Strava Sponsored Challenge rules and regulations.
- 6.2. All Participants need to register for each Nedbank Running Club Challenge on the Strava platform during the designated dates, which is either prior to or during each challenge.
- 6.3. All Participants must complete the challenges by running from point 'A' to point 'A', or multiple loops from point 'A' to point 'A'.
- 6.4. Participants are not permitted to complete any challenge on an athletic track or treadmill. This will result in disqualification from the competition.
- 6.5. The participant's chosen race route must meet the specified minimum distance and elevation requirements (see points 5.3.1 to 5.3.4).
- 6.6. Participants must upload their challenge result onto Strava through either:
 - 6.6.1. A GPS supported fitness device used to record their activity; or
 - 6.6.2. A GPS supported smart phone used to record their activity through the Strava App.
- 6.7. Manual uploading of an activity, or activities submitted as 'Private' will not be considered for the Nedbank Running Club Challenge competition.
- 6.8. The Promoter reserves the right, at any time, to verify the validity of entries and to disqualify any Participant who submits an entry that is in breach of these terms and conditions.

7. HOW TO ENTER THE COMPETITION

- 7.1. All Participants who successfully complete a specific challenge are eligible to win a prize for that particular challenge.
- 7.2. All Participants who have registered for the Nedbank Running Club Challenge Competition and successfully complete a specific challenge will automatically be entered into the draw for the prizes for that specific challenge.

8. PRIZES

- 8.1. The Prizes for each specific challenge, for both male Participants and female Participants, will be awarded to the 10 Nedbank Running club members of each gender with the fastest times:
- 8.2. The Prizes are:
 - 8.2.1. 1st = R6000.00
 - 8.2.2. 2nd = R4000.00
 - 8.2.3. 3rd = R2500.00
 - 8.2.4. 4th = R2000.00
 - 8.2.5. 5th = R1500.00
 - 8.2.6. 6th = R1250.00
 - 8.2.7. 7th = R1000.00
 - 8.2.8. 8th = R750.00
 - 8.2.9. 9th = R600.00
 - 8.2.10. 10th = R400.00
 - 8.2.11. Each winner will be contacted and asked to supply the Promoter with their current bank details in order to make payment of the Prize.

9. SELECTION OF PRIZE WINNERS

- 9.1. The Nedbank Running Club Challenge winners will be announced a month after the completion of each respective challenge.

- 9.2. In the event of a dispute, the decision of the Promoter shall be final and binding on all aspects of the competition and no correspondence will be entered into.
- 9.3. The prize winners will be contacted telephonically by the Promoter.
- 9.4. The Promoter will attempt to contact each winner a maximum of three times. If these attempts are unsuccessful, the winner will forfeit the prize and a new winner will be selected.
- 9.5. The Promoter will arrange to have the prize deposited into the winners bank accounts.
- 9.6. Prizes are not transferable and any prize not taken up for any reason will be subject to a separate draw and shall be allocated in terms of this competition to an additional winner/s. The prizes shall not be exchanged for cash amounts if they are not cash.
- 9.7. The Promoter reserves the right to substitute the prize with another of similar commercial value.
- 9.8. Prize winners only qualify to receive ownership of the prize once all the prize winner's details have been verified and confirmed, including compliance with the rules and satisfying the qualifying criterion set by the Promoter.
- 9.9. Prizes will under no circumstances be handed over or paid to a third party and will only be handed or paid directly to the verified prize winner.
- 9.10. A Participant can only win one prize per challenge in this competition.

10. GENERAL

- 10.1. All information relating to this competition and published on any promotional material shall form part of the terms and condition of the entry.
- 10.2. The Promoter, its associated companies, its agents, contractors and sponsors assume no liability whatsoever or any direct or indirect loss or damage arising from an entrant's participation in the competition or for any loss or damage, howsoever arising.
- 10.3. The Promoter may require the winners (at no fee) to consent in writing to endorse, promote and/or advertise any service of the Promoter. The winners have a right to decline the invitation to use their image in marketing material or to participate in any marketing activities.
- 10.4. These competition rules can be found on the Runified Strava challenge page and on the Nedbank Running Club website.

- 10.5. The Promoter may in its sole discretion amend these terms and conditions at any time, without notice, and such amendments shall be deemed to have taken effect from the date of publication of the revised terms and conditions on the Runified Strava challenge page and on the Nedbank Running Club website.
- 10.6. If required to do so, because of legislative or regulatory reasons, the promotional competition may be terminated immediately and without notice. In the event of such termination all entrants agree to waive any rights they have as a result of the termination and acknowledge that they will have no recourse against the Promoter, its agents, contractors and/or sponsors.
- 10.7. All claims for a prize will be subject to a security and validation check.
- 10.8. All prize winners are responsible for any tax obligations arising out of this competition and the Promoter is not responsible whatsoever.
- 10.9. All Participants agree to be bound by these completion rules.
